

Panasonic – Opportunity to Win His / Her Bundles for uploading UGC

Panasonic UK Opportunity to Win either a His Bundle or a Hers Bundle by uploading user-generated content featuring a Panasonic product to be showcased on the Panasonic UK website (hereafter referred to as “the Competition”) is promoted by Panasonic UK, a branch of Panasonic Marketing Europe GmbH, whose registered address is Maxis 2, Western Road, Bracknell, Berkshire RG12 1RT, UK (“the Promoter”).

Eligibility
